### Are mountainside homes at risk?

Last summer, wildfires burned out of control for several weeks in parts of southern California.

Then recent torrential rains pounded those areas causing massive mudslides in hilly places where protective vegetation had been destroyed. Many homes were damaged or destroyed by either fires or mud. Locally, huge rockslides closed parts of I-40 in North Carolina and Tennessee, Hwy 64 in Tennessee and Hwy 76 in Towns and several other North Georgia counties. Record rainfall in 2009 (I measured 72 inches at our place) was certainly welcome in ending several years of drought, but now the ground is so saturated that it has become highly unstable, especially on steep slopes. Rock formations that were bone dry two years ago now spout streams of water that are weakening their seams, starting crumbling and erosion. Instability can be expected to worsen as heavy rains continue. This prospect raises serious concerns for those who have built on "difficult terrain," i.e. steep slopes. Will the mud and rockslides that have occurred elsewhere where terrain was disturbed by excavation soon begin to affect these sites? How safe are access roads and buildings in such locations? If mountainside structures start eroding, what liability will developers, builders and sales persons face for failing to disclose the risks and county officials for permitting construction? The worst scenario would be for continued saturating rainfall, compounded by shifts in the underlying fault line, to trigger a sizeable earthquake. While this situation may not occur, just the very real possibility is enough to cause rational people to rethink the wisdom of building on unstable mountain slopes.

### Make the effort to be counted!

For weeks we have been watching our mail for the 2010 Census survey. Today, I learned that since we do not receive mail delivery at our street address, but at a post office box instead, we will not be receiving a 2010 Census survey. Why hasn't this information been made public to us through the local media? In a rural county, where many of us do not have the benefit of mail delivery to our homes, how were we to know that we might not get counted in the Census? The census is even more important during these tough economic times. Our congressional representation and percentage of federal and state money to which we are entitled is dependent upon the number of people who live within our county's boundaries. When the 'pot of money' is limited, it is critical that we receive our rightful, proportional share of that money. Every one of us who lives in Towns County must be counted. At the post office what happens if our census survey comes addressed to our street address? The postal service has been instructed that no census correspondence addressed to a street address is to be forwarded to a post office box. It is all to be returned to the census bureau. The Young Harris post office alone has returned over 1000 pieces of census correspondence in recent weeks. 2010 Census survey forms are available to those who have not received one in the mail at both public libraries in Young Harris and Hiawassee. It may be a trip out of the way, but it is so important to all of us who live in Towns County. I urge you to make the effort to make sure we are all counted!

## The Middle Path

Several years ago during a Republican regime, we made the observation that energy companies and defense industries appear to do well under Republicans and that finance and insurance do well in a Democratic regime. The recent signing into law of "landmark" health care legislation would seem to support that observation.

I'm not particularly impressed with this recent gift to the insurance companies financed by the tax dollars of unborn citizens. Republicans posture that this legislation is a great evil which must be repealed at any cost, although it contains provisions which they themselves once promoted and which could have been passed months ago were it not for the fact that this is an election year.

During a six year term a senator barely gets two years to attempt to accomplish something before it's time to start running for re-election; during the two year term of a Congressman, well, you do the math.

The legislation itself is not so much an "overhaul" as it is an attempt by the Democrats and the Obama Administration to hold on to legitimacy. It is the sad product of political posturing, procedural gymnastics and back room compromise that has become the norm for our virtual democracy. I hope I am wrong, but I think it will have little effect on our health care system other than to raise the cost of health insurance and push our economy ever closer to the brink.

An interesting by-product of the health care reform debate is the hubris revealed in the requirement that all citizens purchase health insurance or be penalized.

Never before has a Congress reached so far as to require that citizens engage in commerce. In effect, Americans must now purchase a particular product from a corporation or be fined for failing to do so. Apologists point out that we are required to buy auto insurance, but this is something different. Automobile insurance is regulated by the states and a person can opt out by simply refusing to drive, which many who live in metropolitan areas do. If Congress were truly concerned about the state of healthcare in America a simpler and much more effective measure would have been to outlaw smoking and fast food, which would save billions of dollars and thousands of lives - but we don't resort to such dictatorial measures in the "Homeland;" at least we didn't until now.

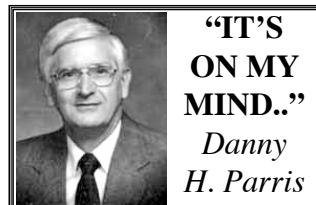

the term "yellow journalism") have made much hay out of the health care debate, and once again while we were distracted by all the theater, news that is truly important has slipped by unnoticed. This year Social Security will pay out more than it receives. Medicare's unfunded liability will exceed \$89 trillion. Social Security's unfunded liability will exceed \$17 trillion. Added together that amount is seven times the size of the US economy.

Pilate, the governor, weak and spineless, admits that "I find no fault at all" (John 18:38).

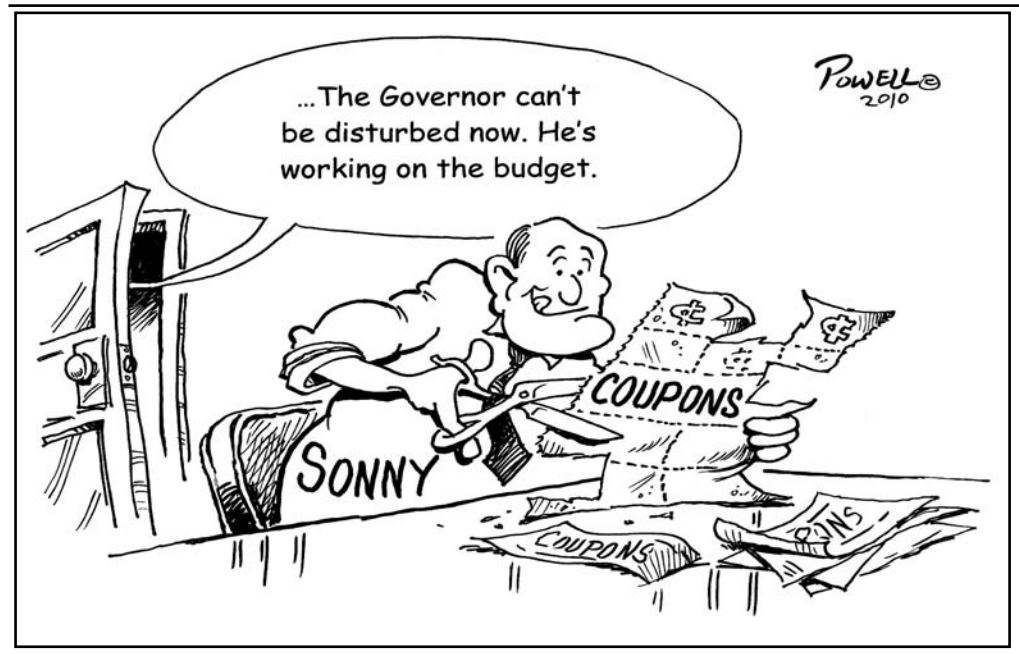
