Kendall speaks to TCHA



Commissioner Bill Kendall spoke to the Towns County Homeowners Association last Thursday night about Lowe's, water and sewer services, and ball fields

First, he talked about a resolution that will increase the Homestead Exemption in the county by \$8,000. He said if the voters pass the resolution on Nov. 3, it will go into effect in the 2010 digest. Kendall told the associa- ciation that he hopes they tion members that if the resolution passes, they will not be taxed on the first \$25,000 of their homes at Fair Market Value.

Next, Kendall said there have been questions about how much taxpayer money is going into attracting Lowe's into the county. "We will not be putting one dime for Lowe's to come," he said. Kendall added the county and city has done all they had to do to get Lowe's to come, and they did not even have to give Lowe's a variance for their building.

"This is not a done deal," he told the association members. He said he will be meeting with Lowe's in January. Kendall finished by saying no one is trying to put the local hardware store out of business, but Lowe's will bring jobs to the county.


