RESOLUTION TO DESIGNATE AN OPEN RECORDS OFFICER FOR THE CITY OF YOUNG HARRIS FOR PURPOSES OF THE GEORGIA OPEN RECORDS ACT WHEREAS, the Georgia Open Records Act, codified at 0.C.G.A. § 50-18-70, et seq. (hereinafter the "Act"), sets forth the law by which public agencies such as the City of Young Harris must provide copies of records to members of the public upon request; and WHEREAS, in 2012, the Georgia Legislature comprehensively revised the Act with the enactment of House Bill 397, which was signed into law by the Governor on April 17, 2012 (Ga. L. 2012, p. 173, §§ 1-38), and the Georgia Legislature has subsequently enacted additional amendments to the Act (together, the "Amendments"); and

WHEREAS, one of the important changes set forth in the Amendments is that agencies (as defined under the Act) such as the City of Young Harris may each designate a "Custodian" who would be the Open Records Officer responsible for receiving open records requests for the agency; and
WHEREAS, since the City of Young Harris desires to ensure responsiveness and complisites to

sires to ensure responsiveness and compli-ance with the Act and to provide a designated official with the requisite skill and expertise necessary to receive and respond to open records requests in compliance with the Act; WHEREAS. designation of an Open Records Of-

and WHEREAS, designation of an Open Records Officer will ensure more efficient processing of responses to open records requests; and WHEREAS, the Act further requires that if an agency designates an Open Records Officer, the agency shall so notify the county legal organ and shall also prominently display such designation on the agency's website. NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of the City of Young Harris, Georgia hereby designates the city clerk to serve as the Open Records Officer for the City of Young Harris, and further designates the deputy city clerk to serve as the Open Records Officer in the city clerk's absence; and BE IT FURTHER RESOLVED, that upon its enactment by the City Council, a copy of this Resolution shall be forwarded by the city clerk to the Towns County Herald, and a copy of this Resolution shall be placed on the City's website, within seven (7) days of the date of adoption. BE IT FIRMALLY RESOLVED, that this Resolution shall become effective upon its adoption, and that all resolutions, and parts of resolutions, in BE IT FINALLY RESOLVED, that this Resolution shall become effective upon its adoption, and that all resolutions and parts of resolutions in conflict with this Resolution are hereby repealed to the extent of the conflict.
