Towns County woman charged with attempted murder

On Monday, Jan. 16, Jacqueline Kay Ford, 61, of Hiawassee, was arrested and charged with one count of attempted murder.

She is currently being held without bond in the Towns County Detention Center.

Towns County Sheriff's Deputies responded to a residence on Scataway Road in Hiawassee during the early morning hours on Friday, Dec. 30, 2016, in reference to a 911 hang-up call.

Upon arrival at the residence, deputies discovered a 79-year-old male and a 61year-old female, both in semi-

Both were initially transported to Chatuge Regional Hospital before being airlifted to Northeast Georgia Medical Center in Gainesville, where they were admitted in serious condition.

The case was investigated by the Towns County Sheriff's Office and the Georgia Bureau of Investigation.

The attempted murder charge stems from Jacqueline Ford adding an unknown amount of prescription medication and antifreeze to a liquid drink and giving it to her husband, Robert Ford, in an attempt to cause his death.


