Commissioner signs proclamation against child abuse

On Tuesday, March 28, Towns County Sole Commissioner Cliff Bradshaw signed a proclamation honoring April as Child Abuse Prevention Month.

The proclamation explains that while children are the most valuable assets that any community has, they are also the most defenseless, and it is the community's civic responsibility to ensure their safety and protection.

Enotah CASA, or Court Appointed Special Advocates for Children, is one of the primary advocate groups for abused and neglected children in the area. The Enotah CASA is aligned with the Enotah Judicial Circuit that covers Towns, Union, Lumpkin and White counties.

Through this system, each child is appointed a CASA

volunteer who advocates for the child's best interests and provides a source of stability for the child.

In recognition of Child Abuse Prevention Month, CASA volunteers have placed dozens of blue pinwheels on the lawn of the Towns County Courthouse as a symbolic reminder of the children who have been neglected and abused.

"There are 217 children that were neglected or abused that had to be removed from their homes and put into foster care," said Linda D'Angelo, Executive Director of Enotah CASA. "We continue to see an increase in the number of children, particularly in Union and Towns County."

"We use pinwheels because pinwheels are the national symbol to prevent child abuse. Pinwheels are whimsical and childlike, and See *Child Abuse*, Page 6A

Fire board kicks off Young Harris fire station

YOUNG HARRIS – The City of Young Harris will soon have a new fire station.

In a meeting of the Towns County Fire Board on Friday, March 31, the board visited the location of the future Young Harris fire station, and set into motion plans to start and finish Station No. 2 this year.

Located about a mile and a quarter up Georgia 66 in Young Harris, the future site of Station 2 will be built upon an acre and a half of land acquired from Eddy Corn.

The fire board will soon be soliciting quotes for a three or four-bay building to be constructed upon the site.

Once the building shell is installed, Towns County Sole Commissioner Cliff Bradshaw and the board plan to have the county do all the interior installation of electrical and See *Fire Board*, Page 6A

Mattee warns of avian influenza at meeting

YOUNG HARRIS – University of Georgia Extension Agent Melissa Mattee shared information on avian influenza and spring gardening tips at the Mountain Movers and Shakers weekly meeting at Mary's Southern Grill on Friday, March 31.

Mattee works as the ag agent for both Union and Towns counties.

According to Mattee, avian influenza can be especially harmful to local poultry, and is a virus that is contracted through direct contact with infected waterfowl, such as Canadian Geese, or the feces of such waterfowl.

Mattee explained that this is not contagious to humans, and should not

be confused with what is commonly known as bird flu, to which humans are susceptible.

"Avian influenza, the strain that is currently being transmitted throughout Tennessee, Alabama and
