of complexities that have come along with the potential purchase.

Kelley explained that he and Mayor Andrea Gibby attended a conference call earlier that day with United Community Bank, the Georgia Municipal Association, and a representative from the Atlanta-based legal firm Smith, Gambrell & Russell, LLP, Attorneys at Law.

"The purpose was to discuss the complexities of a simple real estate loan that hope to be here." we are used to, residential or even commercial," Kelley said. "So, United Community Bank contacted the law firm to assist with this matter, since they are not normally in the business of loaning money to municipalities.'

Added Kelley, "The loan will actually be made to GMA, and we will have a document called a lease purchase agreement with GMA, and they will be the purchaser of record. Once we have fully paid off the loan, it becomes ours, but that is the way that it has to be done."

Young Harris resident Kathy Hughes attended the called meeting, and she asked for more information about the loan, which Kelley thereafter worked to justify.

"We have a lot of people inquiring about using the current City Hall and the area for special events," Kelley said. "We have a lot more requests than we are able to honor, and term vision, but I cautiously tell we are improving the city park, making it a lot more usable for the public.

"As we use more facilities at the current park, we are going to need a larger area to conduct city business. We are anticipating, over the next 10 years, significant expansion of business within the valley.
