It's official – students are back in class

Hiawassee City Council Post 1 qualifying begins Monday

Qualifying for the Hiawassee City Council Post 1 seat will run Monday, Aug. 15, through Wednesday, Aug. 17, from 8:30 a.m. until 4:30 p.m. at Hiawassee City Hall.

The qualifying fee for the seat has been set at \$72.

Currently, the five-seat council only has four members – Liz Ordiales, Anne Mitchell, Jay Chastain and Kris Berrong.

The special election was discussed in the July meeting of Hiawassee Mayor Barbara Mathis and city council, in which the

council held a second reading and adoption of the election ordinance to fill the seat of former councilman Stephen Smith.

"The ordinance sets a special polling times of 7 a.m. to 7 p.m.," said attorney David Syfan in the meeting. "Polling precinct will be here at (Hiawassee) City Hall."

"Any registered and qualified elector within the city that's a resident of the city – they're pretty much synonymous there, but you've got to be a registered voter – can qualify to run for the seat."

"It will be to fill the remainder of the term of Post 1, which would be approximately for one year, one month and 16 days."

Hiawassee embracing upcoming changes

The Hiawassee City Council discussed an upcoming water agreement with Towns County, as well as the new update for the city's Comprehensive Plan at the regular monthly meeting on Tuesday, Aug. 2.

Towns County Chamber of Commerce representative Lynn McPeak, owner of TATA On Main, gave a presentation on the updates to the Hiawassee Comprehensive Plan in the meeting, explaining how citizens can be more involved in the process of writing the new plan.

As with any Comprehensive Plan, Hiawassee's and Towns County's will be required to establish community goals, a general vision statement, policies, and character areas and defining narratives.

The latter two items

refer to specific goals that the city or county see happening sooner, rather than later. The plan itself will be a 10-year plan that is updated every five years.

"Our community is broken into three composites

or three groups," said McPeak. "Towns County, which affects all of us, Hiawassee and Young Harris. There is a survey out that asks you to identify which group you're from. I would encourage you to fill out two,

Sen. Wilkinson saves \$80,000 grant for Towns County road improvements

When Towns County Sole Commissioner Bill Kendall hit a road block trying to acquire grant funds through the Georgia Department of Transportation, he knew exactly who to turn to for help – State Sen. John Wilkinson.

Commissioner Kendall had applied for the DOT's Local Maintenance & Improvement Grant in order to complete much-needed road striping in the county, and though the Gainesville office approved Towns County's application, the state turned it down due to insufficient funds for the total number of grant applications.

"Sen. Wilkinson worked diligently with DOT officials to get the grant reinstated and approved," said Commissioner Kendall, expressing his gratitude for the good work of the senator.

The grant puts \$80,000 of state money toward striping 151 linear miles of county roads, and the county has to provide a 30 percent local

match, which is \$24,000, for a total of \$104,000 in available funds for the project.

YOUNG HARRIS – Towns and Union County Extension Agent Melissa Mattee mulled over matters of lawn and flora care with the Mountain Movers and Shakers during their weekly meeting on Friday, Aug. 5, at Mary's Southern Grill.

This is not the conservative educational group's first encounter with the self-proclaimed "bug lady" – Mattee spoke with the Movers and Shakers for the first time back in March, when she introduced herself to the community and instantly became a hit among the members.

Mattee addressed the group on topics of current relevance at the extension office – proper care, black knot fungus, fire blight

"It's really important, if you have any grass at all, to have upkeep to prevent erosion and maintain greenery around your home," said Mattee. "September is a

really important month for our grasses, whether you're establishing a lawn or just maintaining it."

According to Mattee, grass in the North Georgia
