

Sheriff's Office investigates Bell Mountain Park vandalism

On Thursday, November 3, 2016 deputies with the Towns County Sheriff's Office responded to the top of Bell Mountain in reference to vandalism which had occurred. In recent days, there have been several incidents which have been discovered where subjects have spray-painted the parking lot, observation platforms, walkways, and safety fences.

The County allows spray painting rocks only.

The new wintertime hours for Bell Mountain Park are 8 a.m. to 8 p.m., and the park will be closed from 8 p.m. to 8 a.m. This is seven days a week and effective immediately. The County has asked the Sheriff's Office to enforce the hours of operation. Any-

one who enters onto the park property during hours that the park is closed is subject to being cited for criminal trespass. The Sheriff's Office just wants to make sure that everyone is aware of the established hours that the County has closed the park.

Investigators with the Sheriff's Office are investigating the reported incidents of vandalism. Anyone with information as to the names of the subjects who are responsible for the vandalism are asked to call the Towns County Sheriff's Office at 706-896-4444.

A \$2000 reward is being offered to anyone who provides information that leads to the arrest and conviction of those responsible for the vandalism. T(Nov9,H2)SH

While physical abuse leaves bruises and scars, financial abuse is the number one

reason that survivors return to abusive relationships. Recovering from physical and emotional abuse can pose many challenges for survivors, but the short and long term effects of financial abuse can be devastating.

In the short term, access to assets is imperative to staying safe. Without assets, survivors are often unable to obtain safe and affordable housing or the funds to provide for themselves or their children. With realistic fears of homelessness, it is little wonder that survivors sometimes return to the battering relationship. For those who manage to escape the abuse and survive initially, they often face overwhelming odds in obtaining long-term security and safety. Ruined credit scores, sporadic employment histories, and legal issues caused by the battering make it extremely difficult to gain independence, safety, and long-term security.

Support in Abusive Family Emergencies' Child Advocate, Julie Mashburn, has been assisting families to enjoy the first winter holiday after moving Out Of shelter. Last year, through the support of generous donations from community members, Mrs. Mashburn was able to arrange gifts for over 150 children that had been served through S.A.F.E.'s programs for victims of domestic violence, sexual assault, and child abuse. Providing this outreach service to survivors during the winter allows for a celebration during an otherwise financially challenging time of the year.

During the month of November, Mrs. Mashburn will be busy contacting S.A.F.E.'s past clients from 2016 to assess their need for assistance to be able to celebrate with their children. Businesses, individuals, and churches are encouraged to adopt a family - or two - to help provide a special holiday treat for those who have suffered from abuse.
