To the Editor:

In my recent Letter to The Editor, you added an Editor's note "Hiawassee City Hall Records indicate that Janet Allen recused herself from any vote on the sale of the old city hall. The City also maintains that its charter allows it to sell municipal property."

Your statements imply the information I presented was either wrong at the worst, or less than correct at best. Let me correct that implication.

I would like to see the "City Hall records" documenting Ms. Allen's recusal and the discussion concerning the sale of the old city hall. The copies of City Council Meeting minutes I have are devoid of any details of discussions or records of personal Council Members votes or comments on any issue.

**RARE KIDS;  
WELL DONE**

**Q:** I hate to admit this but I am about as exasperated as it's possible for a sane person to get. For the past year or so our 4-year old has been acting like he's completely deaf, although I've had his ears checked by his pediatrician. Every time I give him instructions he acts like he didn't hear me and goes right on doing what he was doing. I tell him over and over again but he totally ignores me. It's not until I raise my voice - I mean really raise my voice - that I can get him to move. Sometimes I just want to advertise him on eBay.

**A:** Don't put him on eBay; you'd want him back before the day was over. We've had moms try that before. Let me make some observations, then some suggestions. First, ignoring instructions is a learned skill. He has discovered that he can ignore you without penalty until your voice reaches a certain pitch. He knows when you are reaching that pitch. When he hears it he knows that "ignore mom" time is over, and "better do what mom says" time is there. It's actually a little game he has figured out. You have to admit it's pretty clever. Incidentally, a good leader never has to raise their voice. They only have to claim the authority that is theirs.

Second, since he's four you're a bit behind the curve in helping him understand where leadership resides in this family. You are the leader, he is

the led. You make the rules, he carries them out. You can help him unlearn the bad habits and learn new ones. Here's how.

Let me script it: "Andy, daddy/mom and I are making some new rules for our family. Sometimes when we tell you to do something you go right on playing like you didn't hear us. The new rule is that whenever we tell you to do something we want you to say, 'OK, mom,' then stop what you are doing and do as we tell you. Immediately. We will only tell you once." (Mom, you could even do some role playing if you wish at this point. Give him a toy, then ask him to put it in the toy box and go to the other room. Commend him for doing it immediately. If he doesn't, take his hand and illustrate what you mean.)

Continue: "That was wonderful. That's the way we want you to do it every time we tell you to do something." If he forgets, let there be a consequence he doesn't like, such as loss of a privilege, he can't watch his favorite cartoon, he goes to bed right after supper. Something like that. No exceptions here. It may take a couple of weeks to establish a permanent memory, but he can re-learn who's in charge. He probably wouldn't have brought much on eBay anyway.

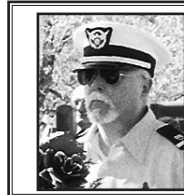
successful companies pay elected officials to create laws and regulations which favor them over other companies. Of course they are competing with other companies that have their own 'employees' in the government."

### USAF/Korean War

#### Volunteer: Vincent Walter Miller

Vince was born April 10, 1932, Indian Head, MD and grew up farming. Tobacco, wheat and corn made up lots of Vince's life when he wasn't playing his trombone for Lackey High School, graduating in 1951. Working at the Naval Propellant Plant, in Indian Head lasted until June 1952 when Vince enlisted in the still transitional USAF, hoping to help our efforts in Korea.

Boot Camp was in Cheyenne, WY where he was pleased to learn that he wouldn't have to live in one of the hundreds of tents, but would be in the new six week boot camp housed in new barracks. He was assigned to the 34 50th training squad (communications) and had already won the "Expert Marksman Rifleman" badge, then still issued by the US Army to AF trainees. Vince was also well versed in certain martial arts disciplines. Tragically on Vince's last day of advanced training, 24 hours before shipping out to Korea, Vince fell from the top of a 50 foot telephone pole and permanently injured his back. He spent one full year in the military hospital in Cheyenne where the AF doctors told him he would never walk again. They didn't know his grit, as he refused to stay down. He also suffered a bout of MS which unexplainably went away. He was then transferred to Denver, CO on light duty and after doing his duty, waiting orders, the base Colonel called him in, gave him "72 hours to get out of that uniform" and an Honorable Discharge.

On his cane, Vince, again back in Indian Head, worked at the Naval Propellant Plant and drove a taxi amounting to many 14 hour days. Living in Clinton (Surratt), MD, Vince and his wife had two sons, Matt and Mark. Sadly his first wife passed. Vince went to work for USPHS, attached to HEW and met his wife Charlotte, married in 1980. Three heart attacks in two weeks led to his decision to retire. Vince attributes the heart attacks to his permanently damaged spinal cord and less than perfect legs. He and Charlotte moved on to Val Rico, FL until 1993, then to Murphy, NC where Vince received awards as head of WNC Community Development and assisted the Sheriff's Department with acquiring much needed emergency equipment for their patrol cars. From there to Young Harris, GA and now in Hiawassee. Vince is active at Macedonia Baptist Church, several veteran committees and our American Legion. He was awarded the Quilt of Honor last year and just got back from the Honor Flight where he was guided in his wheelchair in and around the War Memorials and Washington, DC.

Vince was very positive when asked would he enlist again. "Sure!" "For love of family, Flag and Country!" "There's a good reason for all that happened." "I am fortunate."

All who know and have worked with Vince are fortunate, too. For men like Vince, America is fortunate.
