Attention all fair lovers - the nine-day, 66th Annual Georgia Mountain Fair is rolling back into the Fairgrounds, and will begin on Friday, July 15.

This year's fair will open that Friday with the Flower Show and Boot Stomping shows from Asleep at the Wheel and The Good Routes.

Every year, the fair is the talk of the town, as thousands flock to the fairgrounds to take part in one of the biggest events of the season. From carnival rides to live music, to arts and crafts to old timey culture sprung to life, the fair has a little something for everyone, tourists and locals alike.

"We have all different kinds of entertainment such as Country, Bluegrass, Gospel, all kinds of arts and crafts," said Fairgrounds General Manager Hilda Thomason. "We have 65 booths. We have handmade arts and crafts. The Pioneer Village will be open, which is a live, working Pioneer Village with authentic mountain demonstrations.

EMC nominates seven ahead of fall elections

There will be six names from which to choose this year during the annual Blue Ridge Mountain EMC elections of new board members.

Over the last two years, members have elected six new directors, and the directors have appointed one new director. This year, they will elect two new directors, and vote for the beginning of a new term for Board member Ray Cook, out of Brasstown, NC.

Cook was selected to fill Kenneth Lance's term, following his resignation last year.

Cherokee County, NC would have chosen between Cook of Brasstown, NC., and Thomas Little, of Murphy, NC. However, Little declined his nomination.

Out of Clay County, NC, R. G. (Gary) Reffit, will run in the Hayesville area. His opposition, Adam Cory Payne, of Hayesville, NC.

Out of Union County, comes three candidates Patrick Malone, and Andrew Smith, both of Blairsville, and Gene Mason, also of Blairsville.

The three hope to replace Greg Owenby, who decided not to seek reelection to the BRMEMC Board of Directors.

The nominating committee for BRMEMC chose all the candidates in this election. It's a new twist from the previous two elections. Is it a sign that with the changes by members over the past two years has meant something to members in the five-county area? Maybe so.

BRMEMC Board of Directors President Steven Phillips said if members feel like there is someone out there that should be on the board, call the nominating committee at (706) 379-3121, or (828) 837-1017.

Those still hoping to run as a petition candidate still have until July 18 to get the needed signatures to qualify to run in their respective county.

One person who won't run is Danny Henson, who was dismissed as a board member because of his partnership with fellow board member Greg Owenby.

Henson told the North Georgia News/Towns County Herald on Sunday that he would not seek Owenby's seat. He said he won't say he won't run in the future. As for now, he's content with what he's doing.

Fire department on pace to break record call volume

Towns County Fire & Rescue has been busy since the start of the year, with fires, rescues, motor vehicle accidents and more.

As of late last week, the fire department has responded to 62 motor vehicle accidents for the year, including 23 crashes since May, one of which was Friday's deadly collision on Highway 76 near Sunnyside Road, which required the fire department's hydraulic extraction equipment. "I can remember back in the old days where you might not have that many in a year," said Towns County Fire Chief Harold Copeland. "We're just busy. More people are traveling because of the gas prices, and everybody's coming to the mountains. 'Our numbers have obviously doubled and tripled

Curtis is running for the office of Towns County Sheriff.



Hiawassee Mayor's Park is steadily progressing

Having a Mayor's Park has been a long-term dream for Hiawassee Mayor Barbara Mathis.

Since the beginning of her career, Mayor Mathis has hoped to bring a park into the community to serve as a multi-purpose recreational facility for citizens of all ages from Hiawassee and Towns County

Mayor's Park has been in the works for the past 23 years, with Mayor Mathis and City Manager Rick Stancil staying in contact with the Tennessee Valley Authority off and on in the past few years to check lease availability for

"We're all looking forward to getting it underway," said Mayor Mathis. 'People have really asked us

everywhere we go, when this is going to be completed.

"Before, we didn't have any idea, but now we're looking at a closer date than we have been in several years. So hopefully everything will fall into place and we'll have it running shortly – well, in a little over a year, at least.'

The park was officially

declared a priority to Hiawassee in the City's 2010 Comprehensive Plan, spring boarding the preparations and applications necessary for the park.

TVA leased 6 acres overlooking Lake Chatuge to the City of Hiawassee for the upcoming Mayor's Park, a lease that will span a total of 30 years. When the city begins renovations to the acreage, an appeal to extend the lease for another 30 years will be available, making the lease a proposed 60 years.

"It's a joint venture between a lot of players," said Stancil. "One area of the park, we have subleased to the Department of Natural Resources

"DNR is going to come in this year and put in parking spaces, a boat ramp and a boat dock. So, that's their contribution toward this. We're
