Sgt. Walls gets a promotion



Ledford, Stokes plead not guilty

Two Towns County women charged with the malice murder of a former Union County resident have pleaded not guilty in Towns County Superior Court.

Brittany Elizabeth Ledford, 21, entered a plea of not guilty during arraignment last week in Towns County Superior Court, court records Rebecca Ann Stokes, 32,

attorney David Turk, and Turk entered a plea of not guilty on Stokes' behalf, court records Earlier this year, a Towns County Grand Jury handed up a 13-count indictment against the two women accused of

murdering 53-year-old Diane "Dee Dee" Adams-Donaldson of Hiawassee on June 17th. Ledford, 21, and her reported lover, Stokes, have been charged with felony murder, malice murder, two counts each aggravated assault, tampering with evidence,

and removal of a body from the scene of death, according to the indictment handed up in Towns County Superior Court. Stokes also has been accused of terroristic threats for pointing a gun at Adams-

Donaldson and firing it in her direction, the indictment The murder, according to arrest warrants, occurred

on June 17th at 500 Hickory

body was loaded in a wheelbarrow and rolled to a home that had not been occupied since 1973, according to testimony during an Aug. 4th bond hearing for the two women. Adams-Donaldson's body was dumped in an abandoned well on the property, where it was recovered on July 11th, by law enforcement, according to investigators with the Towns County Sheriff's Office.

Enotah Judicial Circuit Senior Superior Court Judge Murphy Miller denied bond for both Ledford and Stokes following a hearing on Aug. Adams-Donaldson, who

spent a portion of her youth in Union County, was discovered in the old hand-dug well at the old Roper farm on Turner Turnpike in rural Towns County. Adams-Donaldson's remains were recovered approximately at 7 p.m. on July 11th. The well was in close proximity to the residence where Adams-Donaldson lived and was murdered. Adams-Donaldson was

reported missing on June 24th by family members. Ledford and Stokes have
